History of the Organization

The “Backward Community Literacy Development Society (BCLDS)” has come into existence in the year 1991 with the sincere and sustained efforts of like-minded educated and committed social developmental workers of this urban and rural area. To render free and selfless services to the development of downtrodden people as well as other urban / rural poor in the society in the field of Education, Economical, Health and social issues, and also working towards for the development of living environment and improvement of natural resources, by procuring funds from Donors within India and abroad. It has got a devout and social service bent of mind managing committee with CH. Vijaya Babu as its President. The **Backward Community Literacy-Development Society** is a registered Non-Governmental Organization-NGO under the provision of Indian societies registration act XXI of 1860 and registered number is 13/1991. This organization registered under the Foreign Contribution Regulations Act 1976 and the number is 010160302 and Exempted from Income Tax.


The prime objective of our organization is to wake-up the silence masses through education and training for their sustainable self-employment, self-reliance and self-respect without depending on others through various programs without caste, creed and Religion.

Shelter for Urban Homeless sanctioned by (**Ministry of Housing and Urban Affairs, Government of India**) **Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM)** in the year 2018.*{The Deendayal Antyodaya Yojana - National Urban Livelihoods Mission will have a three-tier interdependent structure. At the apex of the structure will be the National Mission Management Unit (NMMU), under the Ministry of Housing & Urban Affairs, Government of India as an independent society under the charge of a Mission Director reporting to Secretary, Housing & Urban Affairs. Till such time an independent society is set up, DAY-NULM* The shelter was inaugurated and started by **Mr Lavanna Commissioner, Kadapa Municipal Corporation**. Since 25-11-2018 we have been implementing the program by the financial support of **Mission for Elimination of Poverty in Municipal Areas (MEPMA)** is a **Government of AP** Society forming part of Department of Municipal Administration & Urban Development and **Kadapa Municipal Corporation**. The purpose of the project is to provide shelter and food for 50 urban homeless. Every day we were providing food, shelter, simple medicine, bathing facility, RO water system and TV for entertainment. The home was started in Rajeev Institute of Medical Sciences (RIMS) Government Old Hospital by the support of MEPMA and Municipal Corporation, Kadapa. 50 inmates (male and female) were gathered from different parts of the Kadapa town that means they were dwelling on Railway flat forms, Temples, footpaths, Churches, Bus shelters by the help of Police Officers, Home Guards, Shelter Care Takers, and likeminded grassroots NGOs supported to BCLDS. By the advice of Hon'ble **District Collector Sri Hari Kiran IAS** BCLDS was named Shelter for Urban Homeless named as **Adarana Shelter for Urban Homeless**, Old RIMS, Kadapa City-516001 in order to identity.


